### THE CHIEF JUDGE AND JUDGES OF THE FIFTEENTH JUDICIAL CIRCUIT KEEP THE COURTS OPEN

As in all other areas of society, COVID-19 has dramatically changed the way the State Courts operate and serve the public. The impact started to be felt in mid-March 2020 and immediately the Chief Judge of the Fifteenth Judicial Circuit, the Hon. Krista Marx, took action. She had two main goals: ensuring everyone's safety AND keeping the courts open and accessible to the public. In her March 18, 2020 Press Release, she stated:

"As Chief Judge of the Fifteenth Circuit, I feel responsible for the safety and well-being of those persons who enter the courthouses of Palm Beach County. I, along with the judges of this Circuit, wish to protect our court users, court staff, and court partners from unnecessary risk. I am very mindful of the COVID-19 public health emergency and the extraordinary, but necessary, social distancing measures required to ensure the safety of us all. At the same time, access to justice is critical for the protection of our society and that necessity does not wane in a time of emergency or crisis. Indeed, there is arguably no time when the need for access to justice is greater."

Under unprecedented conditions, and with the critical help of the Circuit's Court Technology staff, the judges of the Fifteenth Circuit quickly transitioned from in-person hearings to holding essential court proceedings remotely. When it was necessary to hold an in-person hearing, the Circuit employed methods to mitigate the risk of COVID-19 exposure including but not limited to personal protective equipment, temperature devices (contributed by the Sheriff's office), social distancing, and, with the County's help, sanitation services and materials that include hand sanitizer stations and plexiglass for trial courtrooms.

Judicial assistants, court staff, and court partners spent countless hours rescheduling and re-noticing in-person hearings to remote hearings for the public. They assisted attorneys and the public with accessing remote hearings and continue to provide timely assistance whenever needed.

Almost one year later, the Fifteenth Circuit is still open and functioning despite the numerous challenges that accompany operating during a global



pandemic. Notably, from March 16, 2020 to February 5, 2021, the judges and magistrates have presided over 268,500 hearings (remote and inperson). Additionally, respecting the directives of the Chief Justice of the Florida Supreme Court, the Chief Judge has directed a slow return to jury trials, which has resulted in a handful of successful trials

and the resolution of hundreds of cases, on the eve of trial.

The Chief Judge is grateful and appreciative of the dedication and effort expressed by the judges, magistrates, judicial assistants, court staff, and court partners towards ensuring the Circuit's most vital mission: providing access to justice for every Palm Beach County citizen.

#### THE COURIER HAS RETURNED

Welcome to the first addition of the Courier for 2021. The Courier is now up and running again. We plan to return to our former schedule and publish articles related to Circuit events on a quarterly basis. The publication of the Courier was suspended in April 2020 due to the departure of the former Law Librarian, a delay in hiring a new Law Librarian, and then challenges associated with the pandemic. In this version of the Courier, we are touching on some Circuit events that occurred **after** the last published edition (January-March 2020) and notable events that were not published in earlier editions.

I want to take this opportunity to introduce to our readers our new Law Librarian, Mr. Joseph Crisco. In addition to managing the Circuit Law Libraries, his duties include publishing *future* editions of the Circuit Courier. Mr. Crisco was hired right in the middle of the pandemic in July 2020. He has extensive experience with library operations as he worked in the Palm Beach County Library system from 2008 to 2020. Prior to his most recent position with the PBC Library system, he was a teacher for three years. Mr. Crisco is actually an "alumni" of the Circuit. From 1999 to 2004, he worked in our Law Library as a secretary.



During the pandemic, Mr. Crisco has created procedures to ensure that patrons who wish to have access to the Law Library resources can do so, albeit remotely because the Law Libraries remain closed to in-person visitors. Mr. Crisco looks forward to a time when the Law Libraries can be fully functional and fully accessible. Meanwhile, please reach out to Mr. Crisco for any Law Library research needs.

## THE HON. CAROLINE SHEPHERD ELEVATED TO THE CIRCUIT BENCH

The Hon. Caroline Shepherd was elevated to the Circuit bench by Governor DeSantis on October 1, 2019. She first joined the Circuit in 2009 after an appointment to the County bench by Governor Crist. She attended the University of Southern California for her Bachelor's and New England School of Law for her Juris Doctorate.

Prior to becoming a County Court Judge, Judge Shepherd was employed for three years in Miami as an Assistant State Attorney in the 11th Circuit, followed by two years as an Assistant United States Attorney in the U.S. Attorney's office in Washington D.C. She then worked as an Assistant Attorney in the State Attorney's Office in West Palm Beach for seven years.

Her Judicial Assistant, Jessica Wolfkill, has worked with Judge Shepherd since June 15, 2009. Currently, Judge Shepherd is assigned to Circuit Criminal Division R.



## THE HON. MELANIE SURBER APPOINTED TO THE COUNTY BENCH

The Hon. Melanie Surber was appointed to the County bench by Governor DeSantis in December 2019 for a term beginning on January 13, 2020.

Prior to the appointment to the County bench, Judge Surber worked at the Attorney General's Office as a Senior Assistant Attorney General in Criminal Appeals. While there, she appeared before the Florida Supreme Court 20 times. She graduated from Nova Southeastern University with a Juris Doctorate and obtained her undergraduate degree from Boston University.

In March 2020, Judge Surber planned to hold her Investiture but unfortunately it was postponed due to the COVID-19 outbreak.

## CIRCUIT JUDGE EDWARD ARTAU ELEVATED TO FOURTH DISTRICT COURT OF APPEAL



#### JUDGE GILLMAN HOLDS SPECIAL EVICTION COURT

On September 28, 2020, Judge Gillman, assisted by General Counsel, April Bristow, held a special eviction court to address eviction cases placed on hold because of COVID-19. The proceedings were held in the cafeteria to meet social distancing guidelines. Qualified cases were redirected to Legal Aid and Florida Rural Legal Services for settlement using CARES Act funds, acquired by the County for this purpose. Other cases were sent to mediation, facilitated by attorneys from Legal Aid and Florida Rural Legal Services.



### THE HON. PAIGE GILLMAN APPOINTED TO THE CIRCUIT BENCH




The Hon. Paige Gillman was first appointed to the County bench in 2018. She began serving as the Administrative Judge of County Civil in 2019. In June of 2020, Governor DeSantis elevated Judge Gillman to a Circuit Judge seat which was to be vacated on January 1, 2021 with the retirement of the Hon. Jessica Ticktin.

Prior to becoming a Judge, Judge Gillman served as an Assistant State Attorney in the 19th Circuit and as a complex commercial and intellectual property litigator. Judge Gillman now presides over Circuit Civil cases in Division AK and serves on the Florida Bar Small Claims Rules Committee and the Florida Supreme Court Civil Jury Instruction Committee.

Judge Gillman is assisted by Judicial Assistant Alexandra Zamora.

#### CHIEF JUDGE MARX SEATS A GRAND JURY

On October 14, 2020, citizens from Palm Beach County were summonsed for jury service. Potential jurors were kept safe from exposure to the COVID-19 virus through the use of COVID-19 screening questions by court staff before being permitted to enter the court-house. Additionally, jurors were provided a separate courthouse entrance, had their temperature screened, and were required to social distance during jury selection. From the jury pool, the Chief Judge was able to select the necessary 21 jurors who now serve on the Grand Jury. The Circuit appreciates those citizens who responded and appeared for their civic duty. Many thanks, too, to all the court staff and court partners who made this jury selection process successful.



From 2017 to the present she has served as the Chief Judge of the Fifteenth Judicial Circuit. She completes her second term as Chief Judge on June 30, 2021.

Kathleen Kroll, Administrative Judge of Juvenile, and a video from keynote speaker Tony Dungy. 

# JUDGES PRESIDING REMOTELY HELP KEEP THE CASES MOVING

Judges of the Circuit continue to use technology to keep the cases flowing, despite the pandemic. The Circuit Civil judges have held some in-person non-jury trials and jury trials. However, the vast majority of their proceedings occur remotely. On the right is former Circuit Civil Administrative Judge, Lisa Small, on ZOOM, presiding over her Circuit Civil Unified Motion Calendar hearings. Judge Small is currently assigned to the Juvenile bench where she holds both in-person and ZOOM hearings.


Judge Small is assisted by Judicial Assistant Brenda Gleason.

Judge Delgado, like his fellow judges, quickly pivoted to remote hearings to keep his cases moving forward. In addition to ensuring his cases were being timely heard, Judge Delgado, who is assigned to Juvenile Division JS in South County, stepped in to help his Juvenile Judge colleagues in the Main Courthouse. From April to June 2020, he assisted by presiding over shelter and detention hearings, one day each week. The assistance allowed the Main Courthouse Juvenile Judges to focus on rescheduling the in-person hearings to primarily remote hearings, with minimal delay, as well as provided the judges the opportunity to develop a different method for operating the three Juvenile specialty courts located in the Main Courthouse.

Judge Delgado is assisted by Judicial Assistant Lesley Restivo.

## VETERANS' COURT—PRESIDING JUDGE, THE HON. TED BOORAS

Although the pandemic has slowed the number of monthly referrals to Veterans Court (VA Court), the dedicated VA Court Team, lead by the Honorable Ted Booras, continue to resolve cases and connect Veterans to services available at the Veterans Health Care Administration. Many cases are handled remotely. However, if an essential in-person hearing is necessary, the courtroom is well equipped to protect the safety of those present. The County has outfitted the courtroom with plexiglass, all parties must practice social distancing, and mask wearing is mandatory. Despite the challenges poised by COVID-19, the number of cases resolved through the VA Court has not slowed. From April 1, 2020 through January 31, 2021, Judge Booras and the Team resolved 89 cases, whereby 89 individuals were able to benefit from the resources available for Veterans.

Additionally, Judge Booras has resolved many out-of-County cases which include Veterans. Through collaboration with the court partners, 79 cases were resolved by plea agreement. This efficient practice has resulted in individuals spending less time in-custody, allowing them to integrate back into society and saving the taxpayers money.
